

# Message from the Chair



In 2010, the Queensland Catholic Education Commission (QCEC) outreached extensively to its stakeholders to argue, in whatever way it could, for quality Catholic education in the state of Queensland. In many ways, this year has been one in which it was imperative for QCEC to educate others as widely as possible on the benefits and needs of Catholic schooling. The Commission put special effort into preparing materials for distribution to educate its stakeholders about the deficiencies of past funding and the case for better funding in the future.

The distinctive ethos of Catholic education must continue to have the same significant impact as it has done in the past. It is imperative that everybody understands the immense advantages of the value-oriented education that Catholic schools distinctively provide. My fear is that the wonderful efforts of our teachers and parents, and the contributions of our students, will be misunderstood in the general debate, or taken for granted. The Commission enjoys a productive, warm and helpful relationship with Government, and it

is essential that such a relationship continues, especially at times when those on all sides find it hard to predict what lies ahead.

The Commission was both proactive and reactive to the Queensland Government's significant paper, A Flying Start for Queensland Children, and was enormously conscientious in having its views disseminated and understood. As Mike Byrne, the Commission's Executive Director, indicates in his report, the issue of funding at the national level is critical for the future of quality education of our children. That scenario continues and won't come to a conclusion for at least another year. The Commission has been careful to have significant input in the debates that have occurred to date, and it has contributed to discussions as conscientiously and productively as it could.

Without a doubt the most significant religious event in the year was the canonisation of Mary MacKillop. The Commission took great pride, together with others, in the recognition of this marvelous woman, and congratulates the Sisters of St Joseph on giving us such a wonderful role model for the future. The Commission was well represented for the occasion and paid special tribute to the Sisters of Joseph on their return from Rome. I was proud that Queenslanders, including a member of the Commission, took a very active part in the celebrations that were held in Australia and Rome.

My report touches on only a few of the issues that came before the Commission in 2010, and its work seems to get busier year by year. But none of what it achieves is possible without the participation and commitment of those it serves. In this respect, its diverse challenges can't be met without a close relationship with the Bishops of Queensland, and in particular with its Chair, Archbishop John Bathersby, and without the ongoing commitment of the Religious Institutes and other delegating authorities. At the coal face, the Commission also needs parents and teachers to tell them what it needs to hear and know. Finally, I would like to sincerely thank individual members of the Commission, Mike Byrne and members of his Secretariat who ensure that the business of the Commission is always carried out efficiently. I am particularly grateful that so many people give so unstintingly of their time to help the Commission carry out its work.

May God continue to watch over us.

# Report from the Executive Director



The canonisation of Mary MacKillop, St Mary of the Cross on 17 October 2010 was a momentous occasion for the Catholic community in Queensland. The Commission joined with the Sisters of St Joseph to celebrate this occasion and acknowledge the significant contribution of the Sisters of St Joseph to Catholic education in Oueensland.

Catholic education communities across the state joined with the Queensland Government in promoting the Year of Environmental Sustainability and commenced the year with a Sustainability Forum for Catholic school authorities to learn more about school environmental management plans. Catholic Education Week in July also focused its key activities around the theme Called to be stewards of a sustainable future.

At a state level, the Commission engaged closely with the consultation process for the government's discussion paper, A Flying Start for Queensland Children. Together with the government and

the other schooling sectors and key agencies, the Commission also addressed the issues of bullying and violence in schools through its input into the *Queensland Schools Alliance Against Violence* (QSAAV). The work and final report of the Alliance culminated in the *Queensland Schools Declaration Against Bullying and Violence*, a commitment to promoting positive behavior and providing safe environments for learning.

On the national scene, the Commission continued to engage with several key initiatives including the development of the Australian curriculum, the ACARA My School Website and the Building the Education Revolution and Digital Education Revolution programs.

High on the Commission's agenda was the federal government's review of funding for all Australian schools during 2010/2011. In the context of the review the Commission developed resources to ensure that leaders within the Catholic education community were well informed about how Catholic schools are currently funded. The Commission also provided input into the development of the National Catholic Education Commission's response to the review which is ongoing.

These and many other issues on the Commission's agenda often required widespread consultation and collaboration with the Queensland Bishops, employing authorities, the National Catholic Education Commission, government and the state and independent school sectors. I am most grateful for the openness with which these negotiations were able to be conducted.

Once again I especially acknowledge the support of Archbishop John Bathersby and the Bishops of Queensland; the Leaders of Religious Institutes with schools in Queensland; the Diocesan Directors of Catholic education; Therese Temby, Chair of the National Catholic Education Commission; the Hon Anna Bligh, Premier of Queensland; the federal Ministers for Education, the Hon Julia Gillard and the Hon Simon Crean; the state Minister for Education the Hon Geoff Wilson MP; the Director General for Education in Queensland, Julie Grantham and David Robertson, Executive Director, Independent Schools Oueensland.

I also wish to thank my fellow Commission members under the chairmanship of Emeritus Professor Peter Sheehan, the committed and conscientious QCEC Secretariat staff and all those who serve on our many committees, working parties and task forces.

# About the Commission

The Queensland Catholic Education Commission is a 16 member body with certain state-wide responsibilities in respect of the Catholic schools administered by five diocesan (regional) education authorities and 18 Religious Institutes.

The role of the Commission is essentially strategic and has as its principal goal the greater co-ordination and advancement of Catholic education in Queensland. The Commission has an independent chairperson and includes the Executive Director, Bishops' representative, Directors of each diocesan employing authority and representatives of the Leaders of Religious Institutes of Queensland, Federation of Parents and Friends and Diocesan Catholic Education Councils and Boards.

To support its work, the Commission has established a number of committees and subcommittees to draw upon the wisdom and expertise within Catholic education across Queensland. The operations of the Commission are carried out by a secretariat staff based at the Catholic Centre in Edward Street, Brisbane.



# **Key Functions**

The Bishops of Queensland and Leaders of Religious Institutes Queensland have delegated a number of functions to QCEC including:

- negotiating and distributing government funding to Catholic schools
- advocating and promoting the position of Catholic education and liaising with State and Federal Governments and various peak bodies, including the Federation of Parents and Friends, across a range of educational issues
- communicating and responding both internally and through the media to issues relevant to Catholic education state-wide, and nationally in co-operation with the National Catholic Education Commission (NCEC)
- facilitating collaboration between Catholic education employing authorities for industrial relations matters
- facilitating collaboration between Catholic school authorities in areas such as curriculum, information and communication technologies, religious education outside Catholic schools, education for ministry and social justice matters
- researching, collecting and managing relevant statistical data.

# Vision, Mission and Values

### Vision

The Queensland Catholic Education Commission is an agency of the Church in Queensland sharing in the Church's mission to bring the Good News of God's Love to all people.

The Queensland Catholic Education Commission's Vision is that Queensland Catholic education exists to minister, in our respective callings, and to respond to God's love revealed in Jesus Christ.

This response, within the Catholic Tradition, is assisted by nurturing people's holistic formation through the pursuit of truth, liberation from prejudice and promotion of right relationships in daily life in the world.

# Strategic Objectives

# Strategic and Operational Projects

### 1 Supporting the provision of quality Catholic education by school authorities

1.1 To support Catholic school authorities in developing implementation strategies for Catholic education for the roll out of Australian Curriculum through input to various authorities (ACARA, QSA etc).

### **STRATEGIC PROJECT:**

Development of a QCEC Early Childhood Education and Care Position Statement.

### **Purpose**:

The Australian government introduced its *National Early Childhood Development Strategy* which introduced, in partnership with State governments, universal access for four year olds to fifteen hours per week of early childhood education. QCEC was requested to provide information to Catholic education authorities on the impact of this initiative on Catholic schooling.

### **Progress**

The Pre-prep Taskforce developed an Issues Paper which was the subject of some consultation. Subsequently the Commission requested that a QCEC Position Statement *Early Childhood Education and Care* be developed. Various drafts were considered by the Pre-prep Taskforce and Equity Subcommittee in light of feedback received from the Commission. The position statement was approved in September 2010.

1.3 In collaboration with the Bishops and other Catholic agencies, to formulate a QCEC view for advice to Government in relation to planning and implementing schooling in the Pre-preparatory years consistent with the Church's pastoral mission in Queensland.

### **OPERATIONAL PROJECT**

Framework for Early Years Spiritual Development in the Catholic tradition.

### **Purpose:**

The Religious Education Framework is designed for children attending kindergartens located on Catholic school sites and conducted by Church agencies on parish grounds. It has been developed on a solid theoretical base.

### **Progress:**

The project was initiated by decision of QCEC at its 22 June 2010 meeting and approved on 23 November 2010. The framework document was provided to Catholic school authorities for their use.

1.4 To examine and provide support for identifying the possible benefits of the use of information and communication technologies as a strategic tool for teaching and learning and for knowledge management.

### **STRATEGIC PROJECT**

Development of Queensland Catholic Education Network (QCEN).

### **Purpose:**

To develop an ICT network for Catholic education in Queensland which would:

- provide Queensland-wide data network services that meet the collective, emerging needs of the Catholic sector
- enable communication and collaboration across the state including in the areas of teaching, learning, administration and professional development
- provide an ICT infrastructure with network access capabilities that provides connectivity to a range of online services and digital resources
- provide data network services that enable Catholic education to maintain a future focus on the use of ICT in contemporary teaching and learning practices.

### **Progress:**

The Queensland Catholic sector *Network Strategy Review Report* was presented to the QCEC on 24 August 2010. The report reviewed progress in relation a range of strategic initiatives including the Clever Networks Broadband Project Officer, Catholic Network Australian (CNA), Queensland Catholic school authority interconnections, the Online Religious Education Trial and potential state-wide collaborative activities such as online education. The report noted that to a large degree an interconnected state-wide network has been established through CNA. The Commission endorsed the recommendation from the ICT Subcommittee through the Education Committee for an Interoperability Scoping Study to explore the current potential and future requirements for sharing resources and services across the Queensland Catholic sector and beyond in the context of broader initiatives such as CNA and Australian educational reforms.

# Strategic and Operational Projects

### 2 Community engagement, representation and advocacy

2.1 To achieve strategic leadership to enhance accessibility of Catholic schooling to those in need.

### **STRATEGIC PROJECT**

Access to Catholic Schools.

### **Purpose:**

To investigate access to Catholic Education through a state-wide research project which explores the perception that Catholic Education is primarily accessed by the middle class and that students from poorer families are choosing not to attend a Catholic school. Outcomes to be discussed within the forum of QCEC to assist action by Catholic school employing authorities.

### **Progress:**

Following a literature review in 2008 the Commission appointed ACU National as the research agency in April 2009. The final report was presented to QCEC in July 2010. Following consideration of the report's recommendations, these were provided to the Bishops of Queensland.

### **OPERATIONAL PROJECT**

Implications of the Access to Catholic Schools Research Report.

### **Purpose:**

To examine the implications of the Access to Catholic Schools Research Report with a view to preparing recommendations for the Commission.

### **Progress:**

The Catholic Ethos, Formation and Religious Education (CEFARE) Committee is discussing the conclusions and recommendations of the *Access To Catholic Schools Research Report* and testing them against the understandings of what occurs in Catholic schools in Queensland and experiences of working with low SES families with their parishes.

2.1 To achieve strategic leadership to enhance accessibility of Catholic schooling to those in need.

### **OPERATIONAL PROJECT**

Faith Formation of Staff in Catholic Education.

### **Purpose:**

To formulate a framework on faith formation of staff in Catholic education.

### **Progress:**

A draft document has been written from the Colloquium held by leaders of formation for staff in Catholic schools in Queensland. The CEFARE Committee is also examining how to further support Catholic School Authorities with follow up to the Colloquium.

- 2.2 To develop a range of strategies to:
  - renew relationships between QCEC and delegating authorities to the Commission to reinforce the integral place of QCEC and Catholic Education within the Church in Queensland;
  - ii) facilitate ongoing dialogue with delegating authorities and other stakeholders, including emerging structures developed by Religious Institutes, on strategic issues impacting Catholic schooling in Queensland.

### **OPERATIONAL PROJECT**

QCEC Secretariat Leadership Team Workshop on 'emerging entities which are public juridic persons assuming responsibility for Catholic schools previously under the authority of a Religious Institute'.

### **Purpose:**

To develop an understanding of the key issues and implications for the relationship of these entities to QCEC.

### **Progress:**

A key outcome of the understandings developed was commitment to providing a similar workshop for QCEC members early in 2011.

### 3 Funding and stewardship

- 3.1 To develop a comprehensive understanding of the:
  - i) totality of funding and funding needs of Catholic schools
  - ii) particular requirements of children with special needs
  - iii) requirements of rural and remote schools.

3.2 To be proactive in influencing appropriate national and state Catholic education funding models which support the mission and ethos of Catholic education as a whole and with particular reference to the Catholic educational context in Queensland.

### **OPERATIONAL PROJECT**

Analysis of Schools Data.

### **Purpose:**

To analyse the data collected by ACARA for the My School Website.

### **Progress**

The analysis of data collected by ACARA for financial reporting purposes is expected to inform one element. Work undertaken for the NCEC submission to the Review of Funding for Schooling in Australia (Gonski Review) is expected to inform other elements of the operations of Catholic schools.

### **OPERATIONAL PROJECT**

Consultation in relation to the Review of Funding for Schooling in Australia (Gonski review).

### **Purpose:**

To provide advice to inform the NCEC submission to the Gonski Review.

### **Progress:**

QCEC Assistant Director Finance and Resourcing was a key figure in the NCEC working group which developed the NCEC submission.



3.3 To support the promotion of issues relating to environmental sustainability in school facilities and operation.

### **OPERATIONAL PROJECT**

QCEC Sustainability Forum.

### **Purpose:**

Participants were asked to consider strategic directions which they believed would be appropriate to recommend to Catholic school authorities. They were also asked to consider recommendations which could be presented through the Education Committee to the Commission.

### **Progress:**

The very successful forum was held on 1 March. The outcomes informed the development of the QCEC Position Statement on Sustainability.

### **OPERATIONAL PROJECT**

QCEC Position on Sustainability.

### **Purpose:**

To develop a QCEC Position Statement on Sustainability.

### **Progress:**

In December the most recent draft of the QCEC Position Statement *Educating* for Sustainable Futures in Catholic Schools was considered by the QCEC Executive Committee with a view to publication early in 2011.

3.4 To achieve strategic leadership by continuing the development of the data platform Program Information Management System (PIMS) to meet current and emerging needs.

### STRATEGIC PROJECT

Development of Program Information Management Systems (PIMS) – Financial Benchmarking.

### **Purpose:**

To develop a system whereby Catholic schools and authorities in Queensland are able to analyse their income and expenditure and in particular compare it with other Catholic schools with similar characteristics such as size and socio-economic status.

### **Progress:**

The project has progressed in the sense that the financial information is now included with the COGNOS business intelligence tool (not PIMS as originally envisioned). The project will also be informed by the process of examining an alternative methodology to establish contributions from schools applying for capital assistance (essentially using benchmarks) which is under consideration by a committee of the Commission specifically established for this purpose.

The project will also be informed by the current QCEC Group Funding Review and the production of financial data for My School reporting purposes.

### 4 Facilitating the work of QCEC

4.1 To promote a culture whereby those working within and for QCEC fully understand the contribution of their work to the mission of the Church in Catholic Schools in Queensland.

### **OPERATIONAL PROJECT**

QCEC Secretariat Staff Day: Connecting, Valuing, Sustaining.

### **Purpose:**

To provide an opportunity for staff to make connections and build relationships in the context of their work to support the mission of the Church in Catholic schools in Queensland.


### **Progress:**

The 2010 Annual Staff Day was facilitated by Penny Gordon who led the participants in considering their individual and shared goals in the context of the Vision of QCEC and the Mission of the Secretariat. The program also provided opportunities for participants to pray together and reflect on their relationships with one another as a community.

# **Executive Committee**

The role of the Queensland Catholic Education Commission (QCEC)
Executive Committee as the first step in the Commission's decision making process is well defined and reinforced by the fact that its initial meeting in February each year occurs just before the first QCEC meeting and its final meeting is held in December after the last meeting of the Commission in November.

The Committee is responsible for three subcommittees – the Political Advisory Subcommittee, the Student Protection Subcommittee and the Catholic Education Week Subcommittee. These groups provide valuable advice to inform the Executive Committee's work on behalf of the Commission. The separate reports of these subcommittees can be found on the following pages.

To enhance the decision making processes of the Commission, the Committee engaged in preparatory work on such major issues as:

- the strategy for the NCEC Policy Australian Government Funding for Catholic Schools and advice to NCEC regarding the Gonski Review of Commonwealth School Funding
- issues raised in the Queensland Government Green Paper A Flying Start for Queensland Children regarding the proposal to relocate Year 7 into secondary schooling and the proposal to amalgamate three statutory authorities into a single accreditation authority for all schools in Queensland
- the QCEC Access to Catholic Schools Research Project

- revision of the QCEC Constitution
- revision of the QCEC Vision and Mission and the QCEC Strategic Plan for 2011.

Because of the reform agenda of both the federal and state governments, the Committee also spent some time monitoring legislation before both parliaments with a view to recommending advocacy strategies for QCEC to achieve the best possible outcomes for the Catholic sector. In addition, the Committee was active in guiding the process of seeking changes to state legislation around student protection which the Catholic sector had been advocating for some time.

A number of routine yet very important matters which came before the committee were:

- finalisation of the QCEC History Project culminating in the launch of the publication of Many Voices One Message on Tuesday 8 June
- planning for the QCEC Members'
   Formation Day 2010
- management of the appointment process for chairs and members of QCEC committees, subcommittees and working parties.

QCEC is represented on a number of key statutory and other bodies where it is vital that the views of the Catholic education sector are heard. The Executive Committee manages appointments to these bodies and in 2010 nominees and representatives were provided for such entities as:

 Non-State Schools Accreditation Board (NSSAB) – Non-State Schools Eligibility For Government Funding Committee

- Australian Music Examinations Board (AMEB) Qld
- Queensland College of Teachers (QCT) Program Approval Panel
- QCT Returning to Teaching in Schools Program Approval Panel
- QSA Learning Area Reference Committees (LARCs) covering ten school subject areas.

As seen from the above, the issues considered by the Committee are many and varied and provide an agenda which can be very challenging. Since members of the **Executive Committee also are** members of the Commission, they take on a workload which sees them attending eleven Executive Committee meetings and ten QCEC meetings each year. Their tireless efforts on behalf of the Commission and Catholic schooling in Queensland are very much appreciated and are to be commended and applauded.

# Political Advisory Subcommittee

From year to year it might appear that the agenda of the Political Advisory Subcommittee (PASC) undergoes little change. Every meeting there is the dual focus on state and federal contexts and the perennial question -What are the issues where the voice of Catholic education needs to be heard? This sounds fairly straightforward but, knowing that 'a week is a long time in politics', the very experienced PASC members are fully aware of and become deeply engaged in the underlying complexities and intricacies of the political landscape to advise QCEC regarding the issues which may impact on the growth and development of Catholic education in Queensland. 2010 posed many challenges at both state and federal levels, particularly in the federal sphere.

Once again, QCEC is indebted to the Subcommittee members for their dedication and political expertise, particularly those 'voluntary' members who are not usually engaged in the administration of Catholic schooling.

Federally, the Subcommittee worked steadily towards developing the QCEC advocacy strategy to influence candidates in the election for the 43rd Parliament of Australia which was held on Saturday, 21 August. Two important components of this strategy were the key message that the Queensland Catholic education community is a strong contributor to education in Australia and the freely available power point resource presentation *How are Catholic Schools Funded?* 

At the Queensland level, the Subcommittee guided an advocacy strategy that resulted in:

- coordinated meetings within each electorate between election candidates and a Catholic education delegation including representatives of Religious Institute schools
- representatives of most Catholic school communities visiting their local members and election candidates
- invitations to Senators and other Senate candidates to visit schools to engage with children and staff
- meetings with Queensland based Labor and Coalition Members of the House of Representatives
- active engagement of local P & F representatives and P & F diocesan councils
- developing a simple process for receiving feedback on the effectiveness of the strategy to shape future campaigns.

Working in close collaboration with the National Catholic Education Commission (NCEC), QCEC acted on Subcommittee advice and sought to influence the major political parties while recognising the significant emerging electoral support for the minor parties and independents.

When the election result created a hung parliament, it was obvious that this strategy was correct and it paved the way forward for developing working relationships with newly elected members and the new government. Of prime interest were the shifts which may have occurred in relation to the positions of the major parties on the issues raised by Catholic school authorities during the election campaign.

The Subcommittee was also instrumental in developing strategic

advice to guide QCEC input into the development of the NCEC Policy Australian Government Funding for Catholic Schools which would eventually shape the NCEC submission into the Government's review of funding for schooling in Australia.

At state level the Subcommittee maintained its focus on advising QCEC in relation to the approach necessary to achieve improvements in recurrent funding through the 'basket nexus' arrangement with the Government and the political implications of the Government's education reforms. These proposals for reform were set out in the government green paper A Flying Start for Queensland Children and dealt with a number of areas including preparing children for school, moving Year 7 to secondary school and restructuring existing statutory bodies to form a single accrediting authority.

The high cost of these initiatives in a difficult financial climate was a challenge to the state government, and the Subcommittee offered very astute advice regarding the ways in which QCEC might work with the government to achieve the best outcome for all Queensland school children.

As the year concluded, the Subcommittee looked towards 2011 when the term of the current government would be drawing to a close and the newly formed Liberal National Party Opposition would be assessing its direction. With this in mind the Subcommittee began to lay the groundwork for QCEC advocacy leading up to the next state election.

# Catholic Education Week Subcommittee

Catholic Education Week (CEW) was celebrated from 25-31 July 2010 and centred on the theme Called to be Stewards of a Sustainable Future.

2010 was declared the *Year of Environmental Sustainability* for all Queensland schools by the Minister for Education and Training the Hon Geoff Wilson. CEW provided an important opportunity for the Catholic education sector to both partner with the Queensland Government in articulating and demonstrating a commitment to a sustainable future, and in doing so also celebrate God's creation as sacred in the Catholic tradition.

The CEW Subcommittee once again focused its energies primarily on providing impetus and developing resources to support school-based celebrations and activities to help schools communicate the distinctive mission of Catholic education within their local communities. In addition, the Subcommittee planned a launch event at St Mary MacKillop School, Birkdale where the week was officially launched by Archbishop John Bathersby. A State Government Ministerial reception hosted by Parliamentary Secretary for Education and Member for Broadwater Peta-Kaye Croft was also organised by the Subcommittee.

A feature of CEW was the annual presentation of the *Spirit of Catholic Education Awards* to recognise staff members, parents, clergy or volunteers who have made an outstanding contribution to the life of a Catholic school community or Catholic education agency. Response to the awards was again strong with 107 nominations received from across the State.

The following recipients were presented with awards by the Governor of Queensland Ms Penelope Wensley (AO) as part of the official launch event.

Jacqui participated in a number of official functions and visited school communities in Brisbane, Emerald, Clermont and Townsville.

The Commission was once again grateful to the Queensland Teacher's Credit Union (QTCU), Australian Catholic Superannuation and Retirement Fund (ACSRF) and the Australian Catholic University (ACU) for their generous sponsorship of Catholic Education Week.

# Student Protection Subcommittee

2010 was the first year in which the group previously known as the QCEC Student Protection Working Party has operated as the QCEC Student Protection Subcommittee. It's more permanent status as a subcommittee recognises the need for this group to have an ongoing role in an area in which many issues still need to be addressed.

The membership is a balanced representation of school authority personnel engaged in dealing with complaints of harm and abuse at school level, educators, educational administrators and parents. While its primary focus is on the need for Catholic schools and school authorities to be compliant with student protection legislation and regulation, it always considered these obligations in the context of the need for Catholic schools to be proactive in Creating Student Safety in Communities of Care. Other than the obvious state and federal legislation, the most significant context for the work of the Subcommittee is the Australian Government document National Safe Schools Framework.

On a proactive note, the Subcommittee has continued the very successful annual in-service for Catholic School Authorities. This year's theme was Culture of Safety in Schools – Child Protection is Everyone's Business and the program included the topics: implications of the recently published university research report - Teachers reporting child sexual abuse: Towards evidencebased reform of law, policy and practice; A Student Wellbeing Strategy Plan; Commission for Children and young People and Child Guardian (CCYPCG) - Updates on Key Issues; Teachers and Social

Networking Sites: *Think Before You*Post – a legal perspective; and

Revision of the Model QCEC Manual –

Student Protection.

The latter topic was the major agenda item for the Subcommittee this year. The need for revision to create a more 'user friendly' document had been recognised for some time and when the Non-State Schools Accreditation Board expressed concerns about the student protection written procedures of one school authority, the need for action became more pressing. Events of 2010 make it clear that all non-state school authorities will need to give close consideration to the effectiveness of their written procedures and an improved model document is a matter of urgency. As the year ended, a draft document was close to completion.

In the latter part of the year, the Subcommittee spent a considerable amount of time responding to a ministerial proposal prompted by a university research report proposal to amend Queensland legislation regarding the requirements of teachers to report suspected child sexual abuse.

The Subcommittee recommended that this be viewed in the context of a long sought alignment of Queensland child protection legislation where there were differential requirements for state and non-state schools and administrative issues relating to the responsibilities of the "director of a non-State school's governing body" to receive reports of sexual abuse. The issues under consideration were yet to be resolved as the year came to a close.

Other matters on the agenda of the subcommittee included:

- The Youth Suicide Contagion Inter-Agency Project
- Queensland Government Criminal History Screening Bill, which made adjustments to certain aspects of the regulations around the issuing of Positive Notice Blue Cards
- Queensland Schools Alliance Against Violence
- Bullying Complaint Processes in Catholic schools
- Ways of dealing with suspected risk of sexual abuse
- Current policy and procedures for dealing with student self harming behaviour
- Student protection training for high school age volunteers
   Alignment of all Queensland School Authorities reporting forms.

# Catholic Ethos, Formation and Religious Education Committee

### Overview

In providing advice to QCEC, the Catholic Ethos, Formation and Religious Education (CEFARE)
Committee:

- attends to items relating to ethos, formation and religious education referred to it by the Commission
- monitors the implementation of QCEC policies from the perspectives of Catholic ethos, formation and religious education
- identifies, monitors, discusses and makes recommendations regarding emerging issues and needs in Australia and beyond pertaining to Catholic ethos, formation and religious education and where necessary makes proposals to the Commission for relevant research
- supports and co-ordinates at a provincial level collaboration and action arising from the relevant directions that emerged from the Bishops' Research Project Catholic Schools for the 21st Century
- collaborates with, supports, and provides advice to other QCEC committees in all matters pertaining to Catholic ethos, formation and religious education
- considers and responds to State and Commonwealth policies and initiatives from the perspectives of Catholic ethos, formation and religious education, including matters related to the provision of Catholic religious education and chaplaincy in schools outside Catholic schools.

# Finance Committee

The Finance Committee is the principal source of advice to the Commission on finance and resourcing issues including:

- matters related to negotiation, distribution and accountability for the funding of Catholic schools in Queensland by Commonwealth and State Government
- broad funding and financial accountability positions to inform policy direction
- compliance requirements of relevant tax and other legislation with financial implications.

# **Key Activities**

In 2010 the Committee continued to exercise oversight over all financial aspects of government funded programs and ensure that there was an appropriate framework in place to enable effective accountability and compliance with any prescribed requirements. Additionally, the Committee engaged with a number of issues of longer term strategic interests for the Queensland Catholic school sector.

# AUSTRALIAN GOVERNMENT REVIEW OF FUNDING

In April 2010, the Australian Government announced a review of the funding for all schools. The review will determine what program arrangements are put in place following the current 2009 to 2012 funding quadrennium. The review is being undertaken by a panel chaired by Mr David Gonski AC and the panel has commenced consultation with relevant stakeholders, including representatives of Queensland Catholic education.

As part of a coordinated national Catholic school sector response to the review, the Finance Committee has been undertaking preliminary analysis and evaluation of possible school funding models. Input has also been provided into the development of a comprehensive Catholic school position paper that has been provided to the review for consideration. The review is scheduled to deliver its recommendations in 2011 and this issue will continue to be central to the Finance Committee's agenda.

### **REVIEW OF GROUP FUNDING**

Australian Government recurrent funding is distributed to schools under arrangements known as Group Funding. In 2010, the Finance Committee considered issues to do with the operation of Group Funding and concluded that the standard periodic review of the arrangements should be commenced. Based on a recommendation from the Committee, the Commission established a separate review committee to examine the functioning of Group Funding and make recommendations as to how Group Funding should operate from 2013 onwards.

### **ACARA REPORTING**

Under Australian Government legislation, schools are now required to provide information about the sources and levels of income they receive. This information is to be published on the Australian Curriculum, Assessment and Reporting Authority (ACARA) My School website. Although Catholic schools have previously been reporting to government about income and expenditure via the

Financial Questionnaire, ACARA reporting is structured in a different manner and requires extensive data collation and systemisation.

Significantly, data is being provided by all government and nongovernment schools. Therefore consideration has also been given to ensuring that the data across school sectors is as comparable as possible and to providing explanatory materials for school principals, staff, parents and community members.

### KINDERGARTEN FUNDING

The Queensland Government's roll out of kindergarten provision in schools has required deliberation as to how the services can be implemented in a financially viable manner. Both recurrent and capital funding will be provided by the Queensland Government, with QCEC acting as the initial funding recipient. This will require the implementation of an overall kindergarten funding framework that effectively manages the distribution and accountability for funds and supports the ongoing operation of the kindergartens.

### YEAR SEVEN TO SECONDARY

Consideration has also been given to the financial implications of the Queensland Government's proposed move of Year 7 to secondary education. This move will have many capital and recurrent implications and research has been undertaken to assess the anticipated sector-wide costs involved. Included in this assessment is the impact of the move upon primary schools, particularly those in regional and remote areas of the State.

### **OTHER ISSUES**

The Committee has continued to deal with a broad range of financial and compliance issues including:

- The Index of Community Socio-Educational Advantage (ICSEA) used to rank and group schools on the ACARA My School website. The methodology for calculating the index has been revised during 2010 to focus more on parental educational background than on income levels. The ICSEA is calculated for all schools in Australia and may therefore take on greater importance in the classification of schools and possible funding arrangements.
- Duty exemptions legal advice was provided to school authorities setting out the correct procedures for claiming duty exemptions for motor vehicles.
- Financial Health Assessment
  Framework (FHAF) a deed of
  guarantee of financial viability for
  all Queensland Catholic schools
  was negotiated so that the
  schools did not have to
  individually comply with the
  requirements of the FHAF.

- Database development extensive work was undertaken to incorporate financial information and statistics into the COGNOS database. This will enhance the ability to undertake strategic analysis of the resourcing profile of schools and inform future funding policy.
- Financial contributions to capital projects – development of an alternative methodology for determining school financial contributions to projects involving government grants. Consultation has been conducted with all school authorities concerning possible options for implementation. A working party will be established to complete this task.

### **GENERAL OVERSIGHT**

The Finance Committee has a watching brief over all programs of government assistance. In 2010, 8,600 payments were made under government programs as set out below. Further details of program funding can be accessed via the QCEC website included in Table 1.

programs. The Subcommittee
operates with advice from several
subsidiary working parties.

# **Key Activities**

In 2010 the Capital Subcommittee made funding recommendations under particular programs and provided oversight on the administration and delivery of assistance for the following programs:

Significantly, 13 new schools were funded to completion in the 2010 round.

Also during 2010 the Capital Programs Unit carried out facilities audits on all secondary schools in preparation for the proposed move of Year 7 to secondary and was involved in the implementation of the capital funding of the Governments roll out of Kindergarten centres on school sites.

# School Transport Reference Committee

The Non Government School Transport Assistance Scheme is a joint project of the Independent Schools Queensland (ISQ) and the Queensland Catholic Education Commission (QCEC). This scheme consists of two programs, the Bus Fare Assistance and Student with Disabilities Programs.

Parents who reside outside the Brisbane City Council boundaries and meet set criteria have been assisted with the cost of fares to and from school for their children under the Bus Fare Assistance component of this scheme. This assistance has been imperative for many schools in managing their viability. Parents whose children are verified with a disability and meet set criteria have been assisted with the cost of transporting their child/children to and from school under the Student with Disabilities component of this scheme.

Applications are received electronically and uploaded into QCEC's data management program following a rigorous checking procedure through a newly developed staging process. This staging process facilitates continuous improvement for the applicants as well as reducing the risk elements associated with the scheme. Payments are made electronically through the Archdiocesan Development Fund. In 2010 over 4,500 students were assisted with bus fares or the cost of transport to and from school.

QCEC and the Department of Education and Training (DET) representatives have liaised and approved a renewed service agreement for the administration of this scheme. The service agreement is currently with the Government lawyers awaiting their final clearance.

The grants received from the State Government in support of this scheme do not cover the demand for assistance from parents plus the associated operational costs. The State Minister for Education has requested that the eligibility criteria be reassessed in liaison with the Department of Transport and Main Roads (DTMR) and DET. These discussions have been ongoing throughout the 2010 year.

The significance of this scheme is reflected in the demand from parents for assistance, the continued support received from those schools involved in the scheme, and the ever increasing cost of transport.




